Facilities Construction Update

Milam Street has been resurfaced and completed and HISD will pay \$ 27,000 to McLemore Construction.

Gates over the road will now be checked and rewelded/reinforced on Tuesday. Guardian Solutions estimates they have a week to finish up the entry system once the gates are complete. HISD Facility Plan was given to Board Members for strategic planning and goals setting. Football, volleyball, and band schedules were given out.

Recommend approval of Tax Refund Request.

The Board approved the Tax Refund Request as presented for Vickey Bass Procella in Care of Norman P Bass - Life Estate for \$ 627.95 on a motion by Carl Beall Jr, seconded by Gary Parks, passed unanimously.

The approval of TASB Policy Update 113, affecting (LOCAL) policies, to add, revise, or delete (LOCAL) policies as recommended by TASB Policy Service and according to the Instruction Sheet for TASB Localized Policy Manual Update 113 was tabled on a motion by Kim Scales, seconded by Andrea Procella-Heslip, passed unanimously, to be put on next month's agenda. Recommend approval of District's Audit Services.

The Board approved a bid for the District's Audit Services from Alexander, Lankford, & Hiers, LLC for \$ 23,395 on a motion by Janis Speights, seconded by Gary Parks, passed unanimously. Recommend approval to move August Regular Board Meeting date.

The Board approved to move the August Regular Board Meeting date, due to adopting the 2019 - 2020 Budget and Tax rate, to Tuesday, August 27, 2019 on a motion by Andrea Procella-Heslip, seconded by Carl Beall Jr, passed unanimously.
