Security Access Control and Fencing

Southland Fence was unable to come out his week due to illness so hoping to complete the punch list next week. Areas will be identified to address and set up a day for their return to complete the job and address areas of concern. One of those will be to remove the gate lever boxes and replace them with the size needed to accommodate the entry controls to be used. As previously discussed, this change will allow us to forego installing conduit and wiring to these areas.

Guardian Solutions has completed the installs in all areas except the gates. They will be working

with Southland to coordinate the completion of their project.
